In case the ACH transaction is rejected of Non Sufficient Funds (NSF), I understand the Belleville Country Club may at its discretion attempt to process the charge again within 30 days, and agree to a \$20 charge for each attempt returned NSF which will be initiated as a separate transaction from the authorized recurring payment. I acknowledge that the origination of the ACH transactions to my account must comply with the provisions of U.S. law. I agree not to dispute this recurring billing with my bank so long as the transactions correspond to the terms indicated in this authorization form.
