Monthly payment options are available for <u>Full, First year, and Out of County membership options ONLY.</u>
Monthly payments are calculated using the total annual fee divided by 12 months rounded up to the nearest dollar. <u>Please pro-rate your monthly payments to end on 12/31/2024.
