I understand that because this is an electronic transaction, these funds will be withdrawn from my account on the 20th, (except weekends or holidays as stated.) in case ACH transaction is rejected for non-sufficient funds, I understand the Belleville Country Club may at its discretion attempt to process the charge again within 30 days and agree to a \$25 charge for each attempt returned NSF which will be initiated as a separate transaction from the authorized recurring payment.
